The record turn-

out made clear that both U.S. and African leaders share a strong commitment to significantly expanding trade and investment. The U.S. objective at the Summit was to secure key deals and commitments for U.S. companies and establish the conditions to boost U.S. exports and investment in Africa — advancing mutual prosperity in line with the Trump Administration's Commercial Diplomacy Strategy for Africa.
